booking confirmations, emails, and screenshots of the issue. Escalation: If the initial agent cannot help, request to speak with a supervisor or tier-two agent and ask for a case ID. Bank


Chargeback: If Expedia refuses a legitimate refund for unauthorized charges or service failures, contact your bank or credit card provider to dispute the charge directly.

Reasons for Disputes Unauthorized Charges: Bookings you did not authorize. Service



Failures: Hotel, airline, or rental services that were not delivered as promised. Billing Errors:



Duplicate charges or refunds not issued after a cancellation. If you are located in specific regions like Ontario, you may also contact bodies like the Travel Industry Council of Ontario


